

Regular Meeting, Ethan Town Board, 5-9-11

The Town of Ethan board met in regular session on May 9, 2011 at the Ethan Fire Hall at 7:00 pm. Members present were Nancy Schoenfelder, Dale Meinke, Lisa Hjellum and George Puetz. Member absent was Robert Fitzgerald. City personnel present were Sonya Hespe and Bill Kinder. Others present were Gallus Thill, Diane Reinfeld (left at 8:11pm), Anna Jauhola (left at 8:51pm), Ray Wermers (arrived at 7:25 pm, left at 8:10), and Duane Duba (arrived at 8:20 pm).

Chairman Schoenfelder called the meeting to order and led the pledge of allegiance. All motions were unanimously voted as aye unless stated otherwise.

Motion Hjellum, second Meinke to approve the agenda with additions.

The quote of \$6,960.00 from Commercial Asphalt on Ash St. repairs was reviewed. Information about a DOT grant was presented and discussed. Grant could possibly be used for repairing 6<sup>th</sup> St.

Motion Puetz second Meinke to have Legislative Audit to conduct an internal review.

Property owner who received notices last year about nuisance property were ask to inform city by May 1, 2011 of their plans to correct their violations. Abatement procedure will be enforced for those that have not notified the city. Permission was given to Tom Stirling to do a controlled burn on his property if the fire department and his insurance company will allow it.

Motion Puetz, second Meinke to appoint Chairman Schoenfelder and Vice-chairman Hjellum as signatory's on the bank accounts at Farmers State Bank in Parkston and First National Bank in Mitchell

Motion Schoenfelder second Puetz to open a public hearing for the malt beverage licenses.

Motion Schoenfelder, second Puetz to close the public hearing.

Motion Hjellum, second Puetz to approve the malt beverage license application for 2011-2012 for Agland Coop Chubby's Bar, and Ethan Pub & Grill.

Building permit reviewed and approved for Darrah Anderson.

Board declared surplus the old water tower and appraisals will be sought before bids are advertised.

Alumni celebration given approval for parade 10:00 A.M. June 4, 2011 the route will start at park and go west on Main to cheese factory.

Hespe gave the sheriffs report to the board. Board gave approval for Kinder to purchase a laptop computer.

Clean up day volunteers will receive Ethan Bucks for their time and if they provided a vehicle or trailer to help pay for gas and usage, as followed \$30 for Gary Hoffman and Roger Pollreisz, \$15 for Mary Petrik, Layne Hespe, Sonya Hespe, Deb Bigge, and \$10 for Tristan Scott, Wesley Bigge, Brooke Bigge, and T.J. Bigge.

Motion Schoenfelder, second Meinke to send Kinder to Finance Officers School in June, Motion Carries.

Board discussed having land fill opened first Saturday of the month.
