Legislative Notes

86th Legislative Session

Action picked up considerably this past week as Committees began hearing bills and taking action to send them to the floor for final votes. As of January 27, 352 bills had been introduced: 200 House Bills and 152 Senate Bills. It is not expected that many more bills will be introduced as Monday, January 31 is the last day for bills to be introduced by individual Legislators.

The following are actions on SDATAT's bills:

HB 1109: An act to revise certain provisions concerning the township road system.
– *Scheduled for hearing 2/1/11 It would be very beneficial if Township Supervisors and Board Members would contact their Legislators before that and ask them to support this bill (especially those on the House Local Committee: Representatives: Kirkeby, Cronin, Deestra, Feickert, Kloucek, Magstadt, Munsterman, Olson(Betty), Rausch, Schrempp, Tornow, Tulson, Venner). Personal contacts, e-mails or phone calls are all very acceptable.*

HB 1128: Modify distributions from the wind energy tax fund.
-Has been introduced and assigned to House Taxation Committee. No further action is scheduled. It is anticipated that Richland Township and Brookings County will meet and try to reach an agreement at the local level that would negate the need for this bill.

HB 1192: Increase certain registration fees for the use of motor vehicles on the public highways.
-This was introduced on January 27th and assigned to House Transportation Committee. It would increase license plate fee revenue by approximately thirty-one million dollars per year. I plan to ask the Committee Chairman to schedule it for a hearing on February 10 and am hopeful that we can have a substantial number of Township Supervisors present since that is the day after Township Legislative Day at the Capitol – **PLEASE TRY TO ATTEND**

HB 1060: Revise certain provisions concerning how motor vehicle license fees are distributed in the unorganized territories of a county.
Update: Passed House – First read in Senate and referred to Senate Transportation S.J. 227

HB 1097: Provide for the assessment of certain agricultural land as non-cropland.
*Update: First read in House and referred to House Ag. and Natural Resources H.J. 142 – **Scheduled for hearing.***

HB 1098: Revise the limitation on the increases and decreases that may be made to the total taxable value of cropland and non-cropland.
Update: Taxation Do Pass, Passed

HB 1114: Revise the conditions under which contracts with local officials are permitted.
Update: First read in House and referred to House Local Government H.J. 145

HB 1132: Exempt certain seasonal employees from obtaining an applicator license to apply pesticides.
Update: First read in House and referred to House Ag. and Natural Resources H.J. 149

HB 1176: Prohibit county commissioners from providing health insurance for themselves or other part-time county employees.
Update: First read in House and referred to House Local Government H.J. 185

HB 1193: Clarify certain statutes prohibiting political subdivisions from restricting firearms.
Update: First read in House and referred to House Local Government H.J. 195

Senate Bills:

SB 5: Revise the maximum distance from a bridge for posting maximum vehicle weight warning signage.
Update: Scheduled for hearing – 1/31/11- 8 a.m.

SB 96: Revise the fee schedule for certain documents filed with the county register of deeds.
Update: First read in Senate and referred to Senate Local Government S.J. 176

SB 97: Revise the membership of certain local boards of equalization.
Update: First read in Senate and referred to Senate Local Government S.J. 176

SB 99: Revise the provisions that determine the amount of the motor vehicle registration fees that shall be applied based on the age of the vehicles.
Update: First read in Senate and referred to Senate Transportation S.J. 176
